I further understand that woodturning, and the equipment, tools and supplies used in woodturning, including, without limitation, woodturning tools, lathes, bandsaws, chainsaws, drill presses, power sanders and other power equipment, can cause serious injury, temporary or permanent disability, death and/or property damage to persons engaged in woodturning activities and persons located nearby. I agree that when I use KCWT's equipment, tools and supplies, I am solely responsible for the proper and safe use of such equipment, tools and supplies and for my own safety. I understand that KCWT does not provide supervision of the persons using KCWT's equipment, tools and supplies. I understand that KCWT does not provide medical services and that any injury I may sustain may be compounded by negligent or delayed medical service or assistance. I VOLUNTARILY AND FREELY ASSUME ALL RISKS AND DANGERS THAT MAY OCCUR WHEN I AM ON THE PREMISES, WHEN I AM USING KCWT'S EQUIPMENT, TOOLS AND SUPPLIES, OR WHEN I AM PARTICIPATING IN ANY KCWT CLASS, EVENT OR ACTIVITY, INCLUDING, WITHOUT LIMITATION, THE RISK OF INJURY, DISABILITY, DEATH AND PROPERTY DAMAGE, EVEN IF CAUSED BY NEGLIGENCE OF KCWT OR ITS DIRECTORS, OFFICERS, MEMBERS, DEMONSTRATORS, EMPLOYEES, VOLUNTEERS OR AGENTS.

I hereby agree, on behalf of myself, my heirs and my personal representatives, to fully and forever discharge and release KCWT and its directors, officers, members, demonstrators, employees, volunteers and agents ("Released Parties") from any and all claims I, my heirs or my personal representatives may hereinafter have for any injury, temporary or permanent disability, death, damages, liabilities, expenses and/or causes of action, now known or hereinafter known in any jurisdiction, attributable or relating in any manner to my entry upon and use of the Premises, my use of KCWT'S equipment, tools or supplies, or my participation in any KCWT class, event or activity, whether caused by the negligence of the Released Parties or by any other reason. I acknowledge and agree that this Release and Waiver of Liability is intended to be, and is, a complete release, as much as allowed by law, of any responsibility or liability of the Released Parties for all personal injuries, temporary or permanent disability, death, and/or property damage sustained by me while on the Premises, using KCWT'S equipment, tools or supplies, or participating in any KCWT class, event or activity.
